2022 Budget Narrative

We are looking forward to 2022, a year that will bring new ministry opportunities, continuing building improvements and a new pastoral team member:

- In addition to in-person services, we will continue live streaming worship to members near and far. In 2021, average concurrent viewers on Sunday morning was 145.15 viewer screens.
- We will build upon virtual Sunday school sessions, including use of a new technology cart that will allow us to "Zoom" to remote attendees while others are in the buildina.



African American Heritage Walking Tour of Lancaster

- We will continue to expand our work on equality. In October, the Etown CoB Racial Justice Working Group sponsored an African American Heritage Walking Tour of Lancaster. In May, the congregation voted to join the Supportive Communities Network (SCN), a program of the Brethren Mennonite Council for Lesbian, Gay, Bisexual and Transgender Interests. We tabled at the Lancaster Pride Festival in October, providing ministry to our LGBTQ+ brothers and sisters.
- We will continue to provide a home for hundreds of community children and families by hosting the Elizabethtown Community Nursery School (ECNS) & Elizabethtown Child Care Center (ECCC), at an even more critical time during the continuing impacts of the pandemic as families have struggled to find child care.

These ministries and more are planned and facilitated through our Church Board and commissions, with spiritual emphasis and inspiration provided by our pastoral staff. These ministries are funded through the faithful gifts of our members and friends. Here is a summary of our 2022 plan:

> For 2022, the Board presents a traditional operating budget along with an add-on, special capital budget. The 2022 proposed Operating Budget is presented as a challenge budget, while the 2022 Special Capital Improvements Budget proposes to transfer up to \$88,171 from designated Facility Fund monies.



Ministry Salaries, Benefits, and Administration

Our pastors and staff members enhance the life of our congregation as they minister to us, serve with us, make connections with partner congregations, serve the district and denomination, and invest in further education and training. Allocation of our gifts in these areas provides:

- Competitive compensation for our staff members
- Continuing education and development for our staff
- A comprehensive benefits package for full-time staff members
- Expenses for staff and delegate attendance at Annual Conference
- Accounting services, office equipment and supplies

Total Budget for Ministry Salaries & Benefits \$548,822, up 2%

Total Budget for Administration \$35,750, up 15.1%

Faith Formation/Christian Education

The Christian Education Commission has responsibility for providing faith formational experiences through programming that enables participants of all ages to grow in their understanding of God and the Bible. The Commission provides intentional instruction in the faith, which encourages maturity and life application. Expenses include:

- Sunday School materials and resources
- Teacher training and recognition
- Vacation Bible School materials

The Resources Commission oversees our building and grounds to put us in the best position possible to provide ministry within and beyond the walls of the church, now and into the future.

The Resources Commission works to maintain and improve the functionality and appearance of our building. Just a few of the improvements in 2021 included: Elevator (\$162,748.00), flooding cleanup expense (no repairs) (\$11,159.69), security system replaced (\$10,835.00), landscaping (removed old shrubbery and installed new along with mulching). An aged building is constantly calling for repairs: roof, heating systems, generator, dishwasher, etc. Your contributions to the church budget make this possible. Thank You.

Special Capital Budget

The Resources Commission is requesting up to \$88,171 for the following items: roof repair (est. \$24,671), stair tower #2 roof/plaster (est. \$20,000), Boiler temporary fix (\$23,500), Classrooms (2) refurbish (\$20,000). The recommendation from the Board is that funding for the SCI is accomplished through a transfer from Facility Fund designated Building Project funds.

The Pandemic and climate change not only interrupted our individual lives, but also delayed the plans for facility improvement and building construction. Much needed repair, refurbishment, and replacement of aged equipment is sorely needed. The Resource Commission's goal is to maintain a welcoming environment. 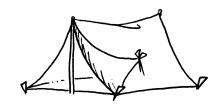

Christian Ed

Children and Youth Sunday School

During the beginning of 2021, our preschool (SHINE) and elementary (BLAZE) Sunday School programming continued to be virtual through the use of videos and occasional zoom sessions. Sunday School curriculum and activities were sent out to families during this virtual time. In June, as the restrictions of COVID-19 loosened, our Sunday School programming became an important part of the church hour. Classes were and continue to be held from 10:15 am until the end of worship. Classes spend the majority of their time outside if possible. This has been extremely important for children to make connections to one another. Masks are in use when classes must be indoors. The Nursery continues to be available during worship for infants ages 0-2.

The Junior and Senior High Sunday School classes continued zoom classes during the beginning months of 2021. Both groups decided to take a break over the summer due to zoom fatigue. Several socially distanced outdoor activities were held over the summer including hikes and campfires. In the fall, the Jr. and Sr. High classes are meeting as a combined group just after the sermon. This year has been difficult to maintain attendance and participation with both groups, but especially with Sr. High. Social gatherings continue to be the highlight for these age groups and we are looking forward to future events and the National Youth Conference trip as a spark to engage these students.

Children's Church

No children's church was held during 2021 as the Sunday School classes were meeting during worship. In the future, we would like to continue to provide this option, but we will need volunteers to staff this program.

Vacation Bible School

VBS was not held this summer due to COVID-19.

Adult Sunday School

We continue to hold adult classes over Zoom. Many guests both within and outside our congregation have been welcomed to these online classes. Speakers have shared and attendees have been able to ask questions and participate in discussion. This online format has and continues to provide an opportunity to engage with persons who are geographically distant from Elizabethtown, PA. We are working on creating a hybrid adult Sunday School classroom that will allow zoom participation to continue even as we begin to meet in-person for Sunday School.

Expressions

The Expressions commission continues to work with the worship planning team to provide innovative and meaningful worship experiences both in-person and online. Throughout a long period during the COVID-19 pandemic, worship at Etown CoB was exclusively online. On June 6, 2021, the worship planning team in consultation with the re-opening committee safely began providing in-person worship services along with the ability to continue to stream online live on YouTube.

Many thanks go to our outstanding A/V team who have tirelessly provided the much-needed expertise and infrastructure to keep worship going throughout the pandemic. While in-person worship attendance is steadily increasing, many still view worship services online live or at a later time. Along with the A/V team, ushers, greeters, and many others work hard in front and behind the scenes to provide a safe and meaningful worship experience each Sunday. All their work is greatly appreciated.

Throughout the Summer and Fall, all preaching responsibilities fell on the Pastor's Pam, Jason and Josh. To provide additional voices, guest preachers were used throughout this time - both in-person and pre-recorded. In August and early September, Pastor Josh was in communication with various vocal groups, and it was decided at that time for the safety of all involved that vocal group rehearsals and participation in worship would be postponed until such time as local Covid transmission rates were lower. Memorial Bell choir was able to begin rehearsing using masks and social distancing to keep everyone involved safe.

While the pandemic has and continues to provide challenges, the resolve and resilience of the Elizabethtown Church of the Brethren continues to shine. Worship planning team continues to receive many words of appreciation and thanks for the continued ministry and sense of community provided through worship. We all look forward to exciting and innovative days ahead as we welcome Pastor Eric to the team!

Nurture

Nurture revisited our mission statement and brainstormed innovative ways in which we could better fulfill our mission.

Nurture Commission has responsibility for the inner mission of the church. The commission shall be responsible for providing experiences that enable persons of all ages to develop faith and grow in Christlikeness as disciples. The Commission shall assume responsibility for opportunities that strengthen the body of Christ by building and nurturing friendships and relationships.

Lenten activities suggestions were sent to the congregation via email, asking them to email back their photos or events and none were received. Lenten devotionals were available through the church office.

Nurture created a virtual Game night which began on January 31 and a second night on February 28, 2021. Very few joined, but those who did, had a very nice time connecting with each other.

Faith Markers-the Blessing of the children was completed with books being delivered, photos taken and a short music video created for these groups of children.

An outdoor movie night was planned, but canceled due to high costs and Covid upticks in the late summer and early fall.

Guess Who's Coming to Dinner was discussed, but again postponed due to Covid upticks and gatherings not happening.

Nurture introduced SCN Supportive Communities Network to the boards & congregation, ending with a "yes" vote to join this organization, which promotes a welcoming environment for LGBTQ+ individuals in churches.

A fall church picnic was planned in combination with the Lititz CoB and this event was a success on Sunday, September 19, 2021.

We hosted an ice cream Sunday in early October that was a huge success, safely outside and enjoyed by many.

Nurture is working to replace the Golden Age dinner group with another "senior" ministry called "Prime Time". This group was introduced to Nurture by Gina Strouse who was inspired by an article she read. We plan to work with Gina to have this group evolve and see where it leads.

Christmas holiday activities:

- Advent we are promoting a devotional called "Do Not Be Afraid", a Brethren Press Advent Epiphany devotional.
- Sending Christmas cards to all shut-ins from Nurture commission, along with small poinsettias, if budget will allow.
- Planning a possible bonfire/Christmas caroling night on Sunday, December 12, to have an outside gathering with hot chocolate and shared individually packed cookies.

We plan to support the Witness Commission in bringing John Pavlovitz to our church for an invigorating fall weekend next year in 2022.

We continue to try to come up with creative ways for us to stay connected from a distance, but long for the time when we can be together again without social distancing and masks restrictions.

Resources

The Resources Committee is actively involved in the day to day operations and maintenance of the church building and the grounds around the building. During 2021 we have our second full year of Amy Zimmerman in place as the Facilities Manager and we have continued to balance the needs of the congregation, the Elizabethtown Community Nursery School, the Elizabethtown Child Care Center and all the various organizations and groups requesting the use of our property and grounds. We have done this while the education wing had to have some quick moving of materials from a Resources Room which was overrun with ancient old materials that had to be sorted through and discarded. This saw the renovation of two areas to provide updated men's and women's bathrooms, which will soon be available for our use.

Along with the challenges caused by the pandemic and climate change, we had some serious issues: flooding which led to major cleanup and unexpected repair expenses. Our slate roof continues to provide leaking issues which in return provides us with plaster repair matters.

As reported last year, a hydraulic leak in the existing elevator did indeed lead us to replace the elevator with an Otis elevator (\$162,748.00). Along with the elevator, the fire panel had to be replaced (\$9,000.00). When it rains, it pours – then the security system had to be replaced (\$10,835.00). The security system is designed to include the expansion of the system

to add additional doors if/when the building expansion can occur. There were many on-going repairs with plumbing, heating, dishwasher, etc.

There have been numerous projects to maintain and enhance the beauty of our building and properties. A special note of thanks to the Landscaping volunteer crew for the beautification project. A big "shout out" to Kurt Sollenberger, Greg Epps, and Al Sollenberger for their engineering the project.

The Resources Committee is ending the year with a continued focus on making the Church facility an inviting and welcoming place in 2022. The November meeting was held on premises with the Board Chair, Moderator, Building Committee, and incoming Board Chair and Vice Chair to plan how we can move forward with our goal. As you can see in the proposed budget for 2022, there is much that can be done to meet that goal.

Building Committee

Throughout the summer and into this fall, you may have noticed construction fencing, dumpsters and other equipment in the church parking lot. Behind that fencing, a lot has been happening!

The Christian Education wing bathroom renovation project, part of Phase I of our renovation/construction plan, includes: elimination of previous men's and women's main level bathrooms and corner storage room in Christian Education wing, which are now Americans with Disabilities Act (ADA) compliant men's, women's, and family restrooms; drywall, painting and finishes (i.e. tile, countertops, vanities, toilet fixtures, and partitions); acoustical ceiling, lights, and HVAC grilles and registers; corresponding downstairs classroom plumbing and ceiling work.

Council activity this year:

- * March 21, 2021 Special Church Council meeting. Congregation voted to approve the phased approach to construction and remodeling. Accepted construction schedule outlined in Phase I and II.
- * May 2, 2021 Special Church Council meeting. Congregation voted to accept the bids totaling \$820,294 for Phase I.

The roof of the Christian Education wing is also included in this phase. We ordered rooftop steelwork (already fabricated and galvanized). The installation of this structural steel is tentatively scheduled for the end of this year. Once the steel is installed, a new roof will be placed, followed by setting of rooftop HVAC units when they arrive, tentatively scheduled for January 2022.

As Phase I work is underway, the building committee has been working throughout the summer to refine Scheme 20 (reminder: a video of Scheme 20 is on our website – scroll to bottom). They have arrived at Scheme 20|Option 5A as their recommended approach. The Building Committee has been in dialogue with the Church Board, Resources Commission and the Finance Committee about Scheme 20|Option 5A.

Church leadership had hoped to bring the design and financial package to the congregation for discussion this fall. We are now planning for a congregational discussion in early 2022. In addition to allowing more time for additional information to be gathered, this will also allow our new pastor to participate in the process.

It is with much thanks that we celebrate the work finished to date, and the many hours and dollars contributed to this effort. Capital campaign dollars received to date — \$ 2,256,546.90! THANK YOU!
